Dues Deduction/CHECKOFF Authorization: I recognize the need for a strong union and believe everyone represented by our union should pay their fair share to support our union's activities. This authorization shall remain in effect and shall be irrevocable unless I revoke it by sending written notice via U.S. mail to SEA during the fifteen-day period commencing with my anniversary date of employment. I acknowledge that my dues deduction authorization is a contractual agreement between myself, as a bargaining unit employee, and SEIU Local 1984, separate from any statutory provisions of NH RSA 273-A.
